

ALL WOMAN TALK PANEL – TERMS OF USE

1. Definitions

In these Terms of Use:

ACP Magazines means ACP Magazines Limited (ABN 18 053 273 546);

All Woman Talk Panel means the online research panel established by ACP Magazines for the purpose of surveying the opinions of Australian women for market and social research purposes;

Member means a person who has been accepted for membership of the All Woman Talk Panel and **Membership** means membership of the All Woman Talk Panel;

Profiling Survey means a survey of a potential Member's relevant personal details that is completed as a prerequisite to Membership and any update of those details that a Member is requested to provide; and

Website means the All Woman Talk Panel website.

2. Membership

2.1 To become and to remain a Member, you must:

- (a) be a female aged 14 years or over;
- (b) live in Australia;
- (c) apply and be accepted for Membership;
- (d) complete the Profiling Survey;
- (e) have an active, permanent email address so as to receive, among other things, invitations to participate in research and the All Woman Talk Panel's newsletter; and
- (f) participate in a survey at least once a year, not including the Profiling Survey.

2.2 There is a limit to the number of Members. ACP Magazines may accept or reject an application to be a Member at ACP Magazines' absolute discretion and without giving reasons. If your application for Membership is unsuccessful, you may reapply for Membership at any time.

2.3 Membership is not transferable.

2.4 The Privacy Policy of the All Woman Talk Panel (which is available [here](#)) forms part of these Terms of Use.

2.5 By becoming a Member, you agree that you have consented to receive emails from ACP Magazines in connection with the All Woman Talk Panel, including emails inviting you to participate in research and emails attaching the All Woman Talk Panel's newsletter.

3. Termination

3.1 ACP Magazines may, at ACP Magazines' absolute discretion, suspend or terminate all or any part of the All Woman Talk Panel by giving notice generally to Members at any time.

3.2 A Member may cancel Membership by sending an email to support@allwomantalk.com.au and inserting the words "Request Removal" in the subject line.

3.3 ACP Magazines may, at ACP Magazines' absolute discretion, suspend, cancel or terminate a Membership, at any time and with immediate effect including without limitation suspension, cancellation or termination because, in ACP Magazines' opinion, the Member no longer complies with the ongoing requirements as stated in paragraph 2.1 above.
